5. If you are applying as a **foreign student**, you must submit a valid **RSA visa** and a study permit. The permit should state clearly that you intend to enroll as a student with **OXIFA**. Furthermore, the duration of the permit must exceed or be the same duration as the course.

These Conditions of Registration ("Conditions") apply as between the applicant ("Student") registering for their course and OXIFA

OXIFA REGISTRATION FORM (*"Guidelines"*) to Conditions are attached.

1. FEES PAYABLE:

The fees payable to OXIFA in respect of the study of the courses comprise the following:

1. The non-refundable registration fee, payable immediately on submission of the application form annexed hereto;

3. STUDENT'S CURRICULAR OBLIGATIONS:

1. Students have a period of 18 MONTHS within which to complete a certificate Qualification on distance learning
 2. Fees for distance learning is non-refundable
- a) **CORRESPONDENCE-** to succeed with correspondence studies, you need to be hardworking and self-reliant. A vital part of distance learning is the experiential learning component, which requires you to work in the field, shadowing, assisting and learning from other professionals. 1. These Conditions, the annexes hereto and the registration forms will in all respects be governed by and construed under the laws of the Republic of South Africa.
2. The Student consents to the non-exclusive jurisdiction of the Magistrate's Court in terms of section 45 of the Magistrate's Court Act No.32 of 1944 (as amended) having jurisdiction under Section 28 of the said Act, notwithstanding that the claim by **OXIFA** exceeds the normal jurisdiction of the Magistrate's Court as to amount. The Company shall, in its discretion, be entitled to proceed against the Student in any other court of competent jurisdiction, notwithstanding the foregoing.
